## INTRODUCTION

In accordance with [L.R.S. 40:1379.3\(R\)\(2\)](#), the Department of Public Safety and Corrections, Office of State Police is providing the following information as a summation of the Concealed Handgun Permit Unit's 2024 Annual Legislative Report. The following report covers the period of **January 1, 2024**, to **December 31, 2024**, and contains statistical information on the number of permits issued, denied, revoked, or suspended and the reasons for such denial, revocation, or suspension to be categorized by age, sex, race, and zip code.

For the last reporting year, **January 1, 2024**, to **December 31, 2024**, the Department issued **3,489** original five-year concealed handgun permits, **1,305** lifetime permits, and renewed **4,423** permits, for a total of **9,217**. During the same period, the Department denied **415** permits, revoked **160** permits, and suspended **356** permits. These statistics are pulled from the Concealed Handgun Permit database and are approximate.

The Louisiana State Police Concealed Handgun Permit Unit was made aware of one (1) concealed handgun permittee incident involving accident or death in 2024. This incident occurred on September 2, 2024 when a concealed handgun permittee's four (4) year old child accidentally shot himself in West Baton Rouge Parish. The child found the permittee's weapon in the glove box of the vehicle and accidentally shot himself in the chest.

## Temporary Permits Issued in 2024

The passage of [Act 465](#) (“**Brandi Trahan Act**”) of the 2016 Regular Legislative Session (**effective August 1, 2016**) enacts R.S. 40:1379.3.2, providing that a person on whose behalf the court has issued a permanent injunction or a protective order to bring about the cessation of abuse and which prohibits the subject of the order from possessing a firearm for the duration of the injunction or protective order may apply to the Deputy Secretary of Public Safety Services of the Department of Public Safety & Corrections (DPS&C) for the issuance of a temporary concealed handgun permit.

The Louisiana State Police Concealed Handgun Permit Unit received **zero (0)** applications for a temporary permit in 2024.

Reasons for Denial		
L.A.C. 55:I:1307.B.2	101	Applicants shall provide all additional information requested by the department within 10 business days of receipt of the request, unless an extension is granted by the department. If any applicant fails to provide all additional information requested by the department, the application shall be considered incomplete and shall be denied.
L.R.S. 40:1379.3 C.(1)(a)	255	Make sworn application to the deputy secretary of public safety services of the Department of Public Safety and Corrections. The providing of false or misleading information on the application or any documents submitted with the application shall be grounds for the denial or revocation of a concealed handgun permit.
L.R.S. 40:1379.3 C.(5)	4	Not suffer from a mental or physical infirmity due to disease, illness, or intellectual disability which prevents the safe handling of a handgun
L.R.S. 40:1379.3 C.(6)	9	Not be ineligible to possess a firearm by virtue of having been convicted of a felony.

Reasons for Suspension		
L.A.C. 55:I:1307(B)(12)	29	Any false statement or improper notarization contained in any report, disclosure, application, permit form, or any other document required by the department shall be a violation of these rules and shall be cause for denial, suspension, or revocation of the permit.
