



Louisiana State Police Centralized Vendor Vetting Program Approval List

As part of the CVVP, identified vendor personnel complete numerous vetting items including a fingerprint based background check, training, and execution of the security addendum that is tracked within CJIS Online.

Upon an individual completing all of the personnel vetting steps, the vendor is provided an official personnel approval letter. Being an approved vendor does not mean every individual has been properly vetted.

While the CVVP facilitates and streamlines personnel vetting requirements, it is your agency's responsibility to identify vendor personnel that would require access and validating that they have been vetted. To complete this, your agency can either go to CJIS Online to validate personnel items (security addendum, security training, and background check completion) OR follow up with your vendor directly to request copies of personnel approval letters.
